What is devolution?

Opportunity for greater responsibility and control over local decisions and spending

How do things currently work?

Spending decisions are made by central Government

Why change?

- Focuses spending on local priorities
- Provides more say over local taxation

This means

Local decisions to be taken by locally elected politicians working with their local businesses on the Local Enterprise Partnerships who better understand local issues, and can be held to account locally

How does it happen?

- Establish a new body where decisions are taken ('Combined Authority')
- Potentially elect a Mayor with responsibility for powers and resources
- Agreed arrangements by all the places involved as well as central Government

What is a Combined Authority?

A statutory body established to carry out powers and responsibilities in relation to negotiated powers

What happens to current councils and services?

- Services continue to be delivered by local councils
- A Combined Authority does not replace current councils and services
- It is not a move towards merging councils

There is no impact on council services as a result of devolution

What will the Mayor and Combined Authority do?

The directly elected Mayor would act as Chair to the Combined Authority and exercise the following powers and functions devolved locally from central Government:-

- Take responsibility for a devolved multi-year local transport budget.
- Oversee a Joint Investment and Assets Board to review all public sector land and property assets for potential unlocking
- Make proposals to help take forward large developments or new settlements





What new powers would the Lincolnshire Mayor and Combined Authority have?

- > Control of a new additional £15 million a year funding allocation over 30 years,
- Responsibility for developing a strategic infrastructure delivery plan
- Chairing an area-based review of 16+ skills and devolved 19+ adult skills
- > Move towards a co-commissioning arrangement for short sentence offenders
- > Work collaboratively to allow more local flexibility with other local services.
- Contribute to the outcomes and objectives in Water Resources Study and Water Management Plan

Government will work with the Combined Authority to agree specific funding flexibilities

The joint ambition will be to give the Combined Authority a single pot to invest in its economic growth

Residents of Greater Lincolnshire have voted on devolution

- Greater Lincolnshire came along way in a short space of time


Next steps?

- > The 10 Greater Lincolnshire Councils vote on devolution proposals
- Establish combined Authority January 2017
- Mayoral elections May 2017
- Devo 2 and beyond more powers and funding returned to Lincolnshire (Health, Criminal Justice, etc)

Housing

> 25,000 new homes to be built by 2016

- 100,000 new homes by 2030
- Lincolnshire Lakes application for new Garden City submitted July 2016
