Q4 – How do you think we can best develop the Rural Health Network and engage more health and social care professionals working in this field of interest?

- Also bear in mind other Authority contacts – I work for the EU funding team in Norfolk – working up rural funding projects.
- Website with Best Practice examples and detailing projects like those featured at the Conference. Send email updates detailing latest developments.
- IT is not always possible and other ways need to be developed also People/Carers on the ground.
- Distribution of information (relevant) digitally.
- More engagement from local NHS Trusts.
- May I have the last 3 slides from Tracey Roose – see email – Graham’s first slide on website. (Cllr Madge Shineton)
- More training for PHE on working with public sector – Local Authorities in particular stop the silo.
- A social rural network session in London does make me wonder – use current professionals to (advale?) for this topic.
- Greater cooperation with (co-op?) party Local Government.
- Use and work with District Council Network and County Cllrs Network. Use your members to network with local Cllrs and Health Colleagues.
- Build on the ideas presented by Cumbria Forum. Target your energies on areas with biggest inequalities and worse outcomes – bring in learning from “best in class”. Sharing your case studies with us.
- Involve professional colleges leads working on IT and advantages for remote/rural populations. Create a “big win” e.g. roll out superfast broadband to rural populations.
- Need to engage with LMATS/CCGS Health Trusts to not duplicate.
- Could you use regional PHE networks to engage Public Health.
- Keep in touch. Circulate contact details.

Q5 – How could your Organisation/Authority help support the roll out of the Rural Health Network and get involved in building its membership?

- Happy to participate in knowledge exchange.
- We subscribe and we report the Conference to our Members via our website.
- Good communication and be well informed.
